

WHEN AN ACCIDENT OCCURS YOU ARE REQUIRED TO:

1. Report the accident by calling 1-888-967-5222. If you have questions about the prescription program through Carlisle Medical, call 1-800-553-1783.
2. Make sure a post accident drug test is administered. If you have questions or problems obtaining a drug test, call 1-800-833-9412.
3. Use an AlaMed provider listed below if there is one located in the area where the injury occurred.

CompTrustAGC requests that you use an AlaMed Healthcare provider if there is one where the injury occurred.

NOTICE: NEW WORKERS' COMP LAW !!!

Alabama law and recent court decisions make it mandatory that you report an accident/injury that you sustain on this job within 5 days, or workers' compensation WILL be denied by the workers' compensation adjuster.

REPORTING RULES:

1. Report accident/injury to your supervisor/superintendent. **NOT A FELLOW EMPLOYEE.**
2. Give Date and time of the accident.
3. Give specific details—where, when, how and what happened.

Late reporting will be considered fraud and fraud is a crime. There is a \$500 reward for reporting workers' compensation fraud.
